KEY DEVELOPMENTS LAUNCH OF SDG SECTOR ROADMAP GUIDELINES

Leveraging the power of collaboration to drive SDG impact At WBCSD's Liaison Delegate Meeting in Montreux, we released a set of guidelines relating to the development of <u>SDG Sector</u> <u>Roadmaps.</u> This resource lays out a step-by-step process that companies from the same sector can follow as they come together to explore, articulate and realize a common vision for how their industry can contribute to the realization of the SDGs.

The Business & Sustainable Development Commission's *Better Business Better World* report made a compelling case for companies to come together with peers at the sector level to develop SDG roadmaps as a means of guiding their industry's shift to sustainable development in line with the SDGs. Against this backdrop, WBCSD, in collaboration with ERM, has developed these guidelines which provide a structured framework and approach that companies can follow as they embark upon SDG road-mapping for their sector.

This framework leads companies through a process of establishing their sector's current level of interaction with the SDGs throughout the value chain; identifying the sector's most significant opportunities for impact; and establishing key action items and monitoring systems in order to chart a course towards the sector's 2030 vision.





KEY DEVELOPMENTS BLENDED FINANCE TASKFORCE - NEW ACTION PLAN

A roadmap for mainstreaming private investment in the SDGs through blended finance In April, the <u>Blended Finance</u> <u>Taskforce</u> - an initiative emerging from the Business & Sustainable Development Commission released an ambitious new <u>plan</u> <u>of action</u> to increase mainstream private investment for the SDGs.

The plan lays out a series of eight key initiatives to help accelerate access to the necessary financing needed to achieve the SDGs, most notably in the field of infrastructure. The initiatives are drawn from recommendations made in the <u>Better Finance, Better World</u> report. Each of the initiatives has key targeted outputs with deadlines in the next 6 -18 months and identifies a key team of champions who will work to drive each initiative forward.

Champions of the initiative include leaders from across the investment and development finance community including JPMorgan Chase, HSBC, Credit Suisse, Aviva, Investec, Allianz, EBRD, the IFC and the Rockefeller Foundation.

KEY DEVELOPMENTS UN-LEVEL DIALOGUE ON THE ROLE OF SDG REPORTING

Corporate reporting has a critical role to play in communicating performance against the SDGs In April, the United Nations Conference on Trade and Development (UNCTAD), the International Integrated Reporting Council (IIRC), the World Business Council for Sustainable Development (WBCSD), and the Royal Netherlands Professional Association of Accountants (NBA) convened a stakeholder dialogue at the UN Headquarters in New York focused on the topic of measuring private sector contribution to the attainment of the SDGs.

The event affirmed the role of business in helping to achieve the SDGs, and emphasized the the importance of corporate reporting in providing information for capital markets and national governments with regards to how companies are contributing to the SDGs and integrating them into their business.

In a joint statement, the four organizations encouraged businesses to align their value creation models with the SDGs and use relevant metrics to measure and communicate on SDG performance, both in the shortterm and long-term.

The statement also called for collaboration between organizations who are developing and issuing guidance for increasing the reach of the SDGs to corporate audiences, and put forward the point that it is important to leverage mainstream corporate reporting as a means of communicating SDG integration, rather than having the SDGs become a new layer of reporting that adds to the existing burden. 7





KEY DEVELOPMENTS LAUNCH OF BETTER LEADERSHIP, BETTER WORLD REPORT

Women's leadership in business critical to the sustainable development agenda

WomenRising2030, an initiative launched by the Business and Sustainable Development Commission, has released a new report titled <u>Better Leadership</u>, <u>Better World</u> which identifies the key leadership competencies critical to success in developing business opportunities in line with the Global Goals.

In particular it underscores the importance of the following six competencies:

- Long-term thinking
- Innovation
- Collaboration
- Transparency
- Environmental management
- Social inclusiveness

The report also goes on to explore the important part that women in leadership roles have to play with regard to the SDG agenda, presenting research that finds evidence that the six critical competencies are more likely to be prevalent in companies with gender-balanced leadership teams than in companies with maledominated leadership teams.

WBCSD's People team has compiled a new briefing which provides an easily accessible narrative around <u>four key</u> <u>megatrends</u> underscoring some of the pressures and opportunities that individuals, communities and societies are facing in today's world. The briefing highlights how the world in which we are operating is: A world on the move – with significant shifts in demographics (both young and aging populations), migration between and within countries, shifting centers of economic power from west to east, and the rapid growth of the online world.

A world that is polarizing – where we see large splits between people's access to human rights and basic needs, incomes within and between nations, political and societal participation, and levels of trust in institutions.

A world that wants to work – where we are seeing significant and rapid developments in terms of the quantity and quality of work, the nature of work, and the very future of work itself.

A world living beyond its means

– not just in terms of environmental impact, but in the financial and social costs of our lifestyles, and the impacts this is having on our wellbeing. This is leading to shifts in consumer attitudes as a result.

WBCSD ACTIVITIES MEMBER & GLOBAL NETWORK SURVEY ON THE SDGs

To enhance our understanding of the specific challenges that business is facing with regards to SDG integration and to explore the most relevant and effective solutions, in February this year WBCSD conducted a survey of its members and Global Network partners in collaboration with DNV GL.

We would like to thank the **244 companies** and organizations from **43 countries** across four continents that responded to the survey and shared their insights.

While we are still analyzing the results in more detail, the survey

confirmed that business is engaged and sees the SDGs as a strategic opportunity.

We are now in the process of leveraging this data to develop a comprehensive report and an accompanying power-point resource, and will make this available in the coming months.

WBCSD ACTIVITIES TALKING SDGs IN CHILE AND BRAZIL

In late April, WBCSD President & CEO, Peter Bakker, met with top executives of our Chilean and Brazilian member companies (CMPC, Masisa, Natura, Votorantim Cimentos, Vale and, CPFL Energía) during a 4-day visit to Santiago and São Paulo.

A series of closed roundtables and public events organized by WBCSD's Global Network partners <u>Acción Empresas</u> and <u>BCSD Brazil</u> (CEBDS), provided opportunities to engage a number of decision-makers across a wide range of industries around the topic of the Sustainable Development Goals and to highlight WBCSD's work in this field.

It was clear throughout these conversations and engagements that the SDGs play an increasingly important role in business thinking across the region, and there was widespread recognition that the Global Goals will not be achieved without a significant contribution from business, turning challenges into business opportunities for a more sustainable and inclusive Latin America.









EVENTS MONTREUX 2018 - SDG Sector Roadmaps

During WBCSD's Liaison Delegate Meeting in Montreux, we launched a set of <u>SDG Sector Roadmap</u> <u>Guidelines</u> which provide a stepby-step framework that companies from the same sector can follow as they come together to explore, articulate and realize a common vision for how their sector can contribute to the SDGs.

During a 90 minute session focusing on this new resource, WBCSD members that have played a leading role in developing and piloting the Guidelines shared their insight and experiences about the roadmap development process and the benefits that have been derived from it. Additionally, members of the Chemical Sector came together for a final workshop to complete the Chemical Sector SDG Roadmap after a year of hard work and discussions. The roadmap will be launched in the coming months.

We also kicked-off the development of a Forest Sector SDG Roadmap, driven by the Forest Solutions Group, which will seek to establish collective pathways to accelerate and optimize the sector's SDG impact on the road to 2030.

EVENTS MONTREUX 2018 – SDG TRENDS & INSIGHT

As part of our SDG Trends & Insight session in Montreux, the WBCSD SDG team provided members with a comprehensive overview of some of the latest developments across the business and SDG landscape.

This included a focus on the emerging concept of SDG benchmarking, with a detailed presentation by Gerbrand Haverkamp, Executive Director of the Index Initiative, the organization that is leading a global consultation on this topic on behalf of the <u>World Benchmarking</u> <u>Alliance</u>.

Initial results from a recent WBCSD member survey on the

SDGs were also presented, highlighting specific challenges that businesses are facing with regards to SDG integration and exploring the most relevant and effective solutions.

Finally a panel of leading organizations including econsense, Ikea, ITC, StoraEnso and Vale shared their insights and experiences on the topic of the SDGs as part of an in-depth discussion on SDG integration.
